<b>FEDERATIONS INVITED</b>	<p>The Organizing Member Federation will invite all Member Federations according to the following principles:</p> <p>All FIG Members Federations in good standing;</p> <p>All regional federations affiliated in their respective national federation;</p> <p>All clubs affiliated in their respective national federation.</p>								
<b>AGE LIMITS</b>	<p>AG1: 12-14 Years / AG2-Juniors 15-17 years / Seniors 18 + years</p> <p><b>All gymnasts must have a valid FIG licence until the end of the event.</b></p>								
<b>JUDGES AND JURIES</b>	<p><b>All judges must have a current valid FIG brevet in the corresponding discipline.</b></p> <p>The number of Juries (judges' panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.</p> <p>The Juries are set up by a draw and directed by the President of the Superior Jury from the judges present at the event. Priority will be given to the judges of highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the President of the Superior Jury may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of EURO 2'000.- to be paid to the LOC until the Definitive Registration date (28 February 2021)</p>								
<b>REGISTRATION DEADLINES</b>	<p>Definitive and Nominative Registrations must be completed by sending the composition of the delegation to the LOC. <b>ENTRY FEES</b>	<p>No Entry Fee will be applied for this event.</p>								
<b>ACCREDITATION</b>	<p>The accreditation will take place at the Hotel Event Info Desk. The accreditations will only be handed out to the Head of Delegation.</p> <p>All delegations must deliver 2 memory sticks with the musics of all routines, national anthem and flag, medical insurance also covers Covid-19, PCR tests 48h before the time of arrival in Turkey, passports of all members and FIG Licenses.</p>								
<b>EVENT FORMAT</b>	<p>The Aerobic Gymnastics International Competition will have Qualifications and Finals in all categories.</p> <p>Aerobic Gymnastics Categories: IW,IM, MP, TR, GR.</p> <p>Qualifications: Participation is not limited by nation/category / age group.</p> <p>The participation in the finals is limited to 2 units per country in each category.</p>

<b>MEDICAL SERVICES</b>	The Organizing Committee will provide a first aid medical service and emergency medical transportation in the competition / training area during the whole competition.
<b>COVID-19</b>	<p>All delegations must bring Negative PCR test results 48h before the time of arrival in Turkey.</p> <p>Upon arrival in Antalya/TUR, all participants will do a PCR-test the day after the arrival at the hotel.</p> <p>After this, if you get a negative result, you are ready to participate at the event.</p> <p>There will be no second PCR-test in the middle of the event, if you don't have any illness symptoms and if you have not been in contact with any positive tested person.</p> <p>At the first signs of illness (chills, weakness, runny nose, cough, fever, diarrhea, etc.), the concerned person should contact the Official Doctor of the competition immediately.</p> <p>After examining, measuring the temperature and oxygen saturation of the blood, the doctor of the competition may decide on the need to pass an additional PCR test. During this time, a patient with a potential diagnosis of Covid is placed in an isolation room in the hotel.</p> <p>In case of a positive result of PCR-test (Covid+), the person is moved to a specially designated isolation room in the hotel, where the LOC Medical Covid19 Team doctors are looking after the person. If the body temperature rises more than 38.5, lowering the level of oxygen saturation below 95%, the emergence of indicators critical for life, the person will be moved by ambulance to the Hospital.</p> <p>All persons who have been in contact with a Covid + person within 2 days before and 10 days after the onset of symptoms in a Covid + patient have to do another PCR test if,</p> <ul style="list-style-type: none"> <li>• they had direct physical contact</li> <li>• they have been in contact with a COVID-19 + patient at a distance of up to one meter for 15 minutes or more, without Personal Protective Equipment</li> <li>• they have been in contact with a COVID-19 + patient at a distance of up to one meter for 15 minutes or more indoor</li> </ul> <p>The test results will be provided within 6 to 8 hours.</p> <p>If the PCR test is negative, no need for quarantine.</p> <p>If the PCR test is positive, the concerned person needs to quarantine in specially designated rooms at the Hotel.</p> <p>The costs of accommodation and all-inclusive during such an isolation period at the hotel are the following ones:</p> <ul style="list-style-type: none"> <li>• <b>During</b> the official dates of the event: no additional costs for the concerned delegation.</li> <li>• <b>After</b> the official dates of the event: same accommodation costs for the concerned delegation.</li> </ul> <p>If delegation members need or wish to do a PCR test at the end of the event before their travel back home, they have the possibility to do so. Please inform the LOC well in advance.</p> <p>All PCR-tests are at the charge of participating delegations and are to be paid cash onsite. <b>(50 € per/person)</b></p> <p>Treatment and all additional costs associated with it are covered by personal health insurance or the delegations.</p>

<b>VISA</b>	Turkey has changed visa regulations as of April 2014 and all the visa applicants should now apply via an online site: <a href="https://www.evisa.gov.tr/en/">https://www.evisa.gov.tr/en/</a>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: <b>30 €</b> per person/day.</p> <p><b>Important! All delegation members must have a medical insurance that also covers Covid-19 (this should be specified in the document) to take part in the event.</b></p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federation or club is responsible for their own transportation and costs.</p> <p>The Travel Schedule Form must be returned to the LOC by <b>29 March 2021</b></p>
<b>LOCAL TRANSPORTATION</b>	The local transportation will be provided by LOC from/to the Antalya Airport (AYT). All the competitions take place in the hotel hall.

<b>FINAL BANQUET</b>	<p>The Final Banquet will be free of charge.</p> <p>All the accredited participants are welcomed to the Final Banquet.</p>
