MEDICAL SERVICES The Organizing emergency med

The Organizing Committee will provide a first aid medical service and emergency medical transportation in the competition / training area during the whole competition.

All delegations must bring Negative PCR test results 48h before the time of arrival in Turkey.

Upon arrival in Antalya/TUR, all participants will do a PCR-test the day after the arrival at the hotel.

After this, if you get a negative result, you are ready to participate at the event.

There will be no second PCR-test in the middle of the event, if you don't have any illness symptoms and if you have not been in contact with any positive tested person.

At the first signs of illness (chills, weakness, runny nose, cough, fever, diarrhea, etc.), the concerned person should contact the Official Doctor of the competition immediately.

After examining, measuring the temperature and oxygen saturation of the blood, the doctor of the competition may decide on the need to pass an additional PCR test. During this time, a patient with a potential diagnosis of Covid is placed in an isolation room in the hotel.

In case of a positive result of PCR-test (Covid+), the person is moved to a specially designated isolation room in the hotel, where the LOC Medical Covid19 Team doctors are looking after the person. If the body temperature rises more than 38.5, lowering the level of oxygen saturation below 95%, the emergence of indicators critical for life, the person will be moved by ambulance to the Hospital.

All persons who have been in contact with a Covid + person within 2 days before and 10 days after the onset of symptoms in a Covid + patient have to do another PCR test if,

they had direct physical contact

- they have been in contact with a COVID-19 + patient at a distance of up to one meter for 15 minutes or more, without Personal Protective Equipment
- they have been in contact with a COVID-19 + patient at a distance of up to one meter for 15 minutes or more indoor

The test results will be provided within 6 to 8 hours.

If the PCR test is negative, no need for quarantine.

If the PCR test is positive, the concerned person needs to quarantine in specially designated rooms at the Hotel.

The costs of accommodation and all-inclusive during such an isolation period at the hotel are the following ones:

- **During** the official dates of the event: no additional costs for the concerned delegation.
- After the official dates of the event: same accommodation costs for the concerned delegation.

If delegation members need or wish to do a PCR test at the end of the event before their travel back home, they have the possibility to do so. Please inform the LOC well in advance.

All PCR-tests are at the charge of participating delegations and are to be paid cash onsite. (50 € per/person)

Treatment and all additional costs associated with it are covered by personal health insurance or the delegations.

VISA	Turkey has changed visa regulations as of April 2014 and all the visa applicants should now apply via an online site: https://www.evisa.gov.tr/en/			
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 30 € per person/day. Important! All delegation members must have a medical insurance that also covers Covid-19 (this should be specified in the document) to take part in the event.			
INTERNATIONAL TRANSPORTATION	The invited participating federation or club is responsible for their own transportation and costs. The Travel Schedule Form must be returned to the LOC by 29 March 2021			
LOCAL TRANSPORTATION	The local transportation will be provided by LOC from/to the Antalya Airport (AYT). All the competitions take place in the hotel hall.
